ABOUT OUR BILLING PRACTICES

Services at St. Joseph’s/Candler Immediate Care Centers and South Georgia Immediate Care Center are provided by and billed by Georgia Emergency Associates.

SELF-PAY PATIENTS

St. Joseph’s/Candler Immediate Care Centers and South Georgia Immediate Care Center welcome self-pay patients. Payment is expected at the time of service. Cash or credit cards are accepted.

INSURANCE PATIENTS

We accept most insurance. Please verify at check-in if we are “in network” with your insurance.

Your health plan expects us to collect a copayment, if applicable, at the time of service. If we are unable to verify your copayment at the time of service or if there is an underpayment, you will receive a bill in the mail from us. If you are using a primary and secondary insurance, the copayment for the primary insurance will be collected.

Payment of your insurance plan deductible, if applicable, is expected at the time of service. If we are unable to verify your deductible at the time of service or if there is an underpayment, you will receive a bill in the mail from us.

Many insurance plans pay for healthcare services provided in an urgent care clinic differently than they pay for a private doctor’s office; your deductible and coinsurance amounts may be different.

At check-in, you signed a Guarantee of Payment (Assignment of Benefits). This authorizes payment directly to Georgia Emergency Associates for all benefits otherwise payable to you. You also signed that you understand that you are financially responsible for all charges not covered by insurance.

If you receive a bill in the mail from Georgia Emergency Associates, payment is expected within 30 days. Non-payment may result in turning over your account to a collection agency, which may adversely affect your credit.
